GENERAL MANAGER REPORT- KARIN SHULMAN REPORTED, RON NEZBIT IS NOW GOLF COURSE MAINTENANCE EXCEPT FOR STABLES. DANNY HOFF IS NOW GOLF OPERATIONS, ANY ISSUES WITH THE GOLF COURSE CAN BE DIRECTED TO DANNY TO INFORM THE MAINTENANCE DEPARTMENT.

FERN LAKE WILL NOT BE DREDGED UNTILL NEXT YEAR. ALL BRIDGES ON THE GOLF COURSE ARE SCHEDULED TO BE REBUILT.

ALSO DISCUSSED WAS THE RENOVATION OF #6 RESTROOM.
