Board Passes Resolution Banning the Feeding of Birds and Squirrels

During its meeting on July 18, 2020, the PMCPOA Board passed Resolution #02-07-18-2020, an emergency resolution regarding wildlife. The resolution reads as follows:

"WHEREAS, the feeding of wildlife, including birds and squirrels, of peanuts, birdseed, hummingbird nectar and other food items has attracted a number of bears into the community resulting in property damage and creating a public safety issue, and WHEREAS, the California De-

PMC Bear and Wildlife Policy

Most residents know there has been a large cinnamon and blonde-coated bear that was breaking windows and entering homes in PMC in recent weeks.

PMC Patrol, on the advice of California Department of Fish and Wildlife (CDFW), had been trying to haze this bear out of the area with several different methods including the use of paintball guns. Our attempts were not successful.

After consultation with the PMCPOA, CDFW came to Pine Mountain Club on July 11, 2020, and killed this bear out of concern for public safety. This was not the outcome the POA nor CDFW had worked towards. Some people applaud this course of action, most are horrified by it.

The bad habits and ultimate demise of this bear is a direct result of human interference with the normal foraging behavior of California black bears. Several PMC residents' negligence of properly disposing of trash, unsecured storage of pet food, outside refrigerators/freezers, open garages with attractants, feeding birds seeds/peanuts, deliberately feeding bears and a multitude of other association rules violations are documented as having directly led to this animal's destruction. This negligence also adversely affected neighboring property owners who were not violating the rules, by drawing the animal to their homes.

PMC Patrol, with the support of the General Manager and Board of Directors, adopted a zero-tolerance policy in regard to wildlife violations (see Association Rules under Article 7 on the PMCPOA website www.pinemountainclub.net).

Violators of Association Wildlife Rules will be issued an immediate citation, which carry fines between \$1,000 and \$4,500.

Please help us protect the wildlife. Please help protect your neighbors. Please be a responsible steward of our forest community. The responsibility belongs to us all.

Are You Prepared for a Public Safety Power Shutoff (PSPS)?

PMCPOA Emergency Preparedness Committee

During extremely hot, dry and/or windy weather, power companies may need to turn off power to prevent wildfires. It could last multiple days in many areas. There are things you can do to prepare for a PSPS.

MAKE SURE YOUR POWER COMPANY HAS YOUR CUR-RENT CONTACT INFORMATION IN ORDER TO RECEIVE NOTICATIONS. Power companies will try to notify their customers in advance of a PSPS.

BEFORE AN OUTAGE:

- Purchase back-up chargers and batteries. Solar cell phone chargers are a good idea.
 - Learn how to operate automatic gates and the garage door manually.
 - Have enough non-perishable food and water for at least five days.
- Create a First Aid Kit with extra medications, including special needs items for infants or elderly or disabled people in your family.
- Talk to your medical provider for advice on electric medical devices and refrigerated medicines. If you have an electric medical device, sign up for your utility's Medical Baseline Program to receive additional notifications.
 - Purchase a battery-powered radio.
- Make sure you have a landline phone with a plain old telephone that does not require power. Cell phones may not work, as cell towers can go out after a lengthy outage.
- Keep mobile phones/electric equipment charged, and gas tanks full. Gas stations may not be open.
- Avoid using candles; have flashlights and battery-operated lanterns with extra batteries.
 - Have enough food and water for your pets.
 - Ensure backup generators are ready and safe to use.
- Freeze jugs of water and freezer packs. Also have coolers or ice chests on hand
- Install carbon monoxide detectors with battery backup on every level of your home.

DURING AN OUTAGE:

- Refrigerators keep food cold for about 4 hours, freezers about 48 hours. There will be tips next month on "Food Safety in a Power Outage."
- Do not operate generators, camp stoves or charcoal grills indoors or less than 20 feet from windows. DO NOT OPERATE A GENERATOR IN THE GARAGE, even with the door open.
- Turn off or disconnect appliances, equipment or electronics. Power can return in "surges" or spikes that can cause damage.

A Message from the Chairman

As many of you know, we had a bear that was breaking into homes several weeks ago, and a few of those homes did not have attractants. Our patrol chief,



our general manager and I were in frequent contact with Fish & Wildlife for over a week in an effort to bring a successful resolution to this problem, and euthanization was the last resort, but in the end, it was necessary.

The Board received several mails containing various suggestions and demands about feeding the wildlife, fines, leniency, rules, etc. Those emails were forwarded to all of the directors.

In the past two years, the Board has not shown leniency to those who have been feeding bears, and we have supported a zero tolerance for those violations. We have issued citations and we have fined to the maximum level allowed. This past year, our patrol officers handled more than 130 calls related to bear activity, and more than

60 calls related to other wildlife. I believe efforts to educate our members and guests on this issue shows we have not ignored the situation – but some of our members and guests have ignored our rules and suggestions. If you see a violation, please call.

There is no freedom of information act pertaining to PMCPOA. We are a community development, and access to information is regulated by the Davis-Stirling Act, California Codes and our governing documents. We can't publish nor share the names of members who have violated our rules or those who have been issued a fine but we can share that a fine has been issued for a specific violation, and we will be looking at how to best share that information. I will share that the Board had 11 hearings on July 18 for fines issued that included an unleashed dog, open fire, loud noise, trash left outside (x2), lot not properly maintained and the discharge of a firearm.

The issue of racism was being discussed locally. I think I can safely speak on behalf

of the Board in saying that we do not support racism. We do have rules against harassment. Community forums are a means to discuss the issue. If acts of racism rise to the level of criminal activity or suspected activity, we strongly encourage you to contact the Sheriff's Department to report any or all related activity. We will assist law enforcement and members as we are able to do so.

Phases 1 and 2 of the clubhouse renovation continue, and if you've passed by the clubhouse recently, you will see the progress firsthand. There are walls being raised and ramps being constructed, and by the time you read this message, the pool itself should have further progressed after addressing an unanticipated storm drain that required relocation.

Our efforts to keep our community safe during the pandemic truly appears to be working: California has become one of the hot spots, but we have not due to our diligence and member cooperation. We appreciate your continued support. Please be safe!

It is not fair to those who take pride in their yards and keep them up. If you are caught, you can be fined up to \$1,000 for the first offense per Association Rule, Article 2.01.

CONCERNS

• I saw a description of "Pool Progress" in the Condor with pictures of heavy earthmoving equipment, and under that was the admonishment, "Reminder to Conserve Water" that states, "Use of water... for construction cleanup or dust control is prohibited." Setting aside the issue of dust control, how can reworking of surface elevations (aka, grading) be accomplished without the use of a considerable amount of water to ensure proper soil moisture for re-compaction? There is also a considerable amount of water required for other

construction-related activities – particularly the placement of concrete – not including the cleanup of tools and equipment.

Assuming these water-use restrictions apply to PMC community construction projects, as well as our private residential ones, what is the impact of such water usage on our water resources predicted to be, ideally made by an independent professional hydrologist? If groundwater is our only source of potable water for the community, and it takes thousands of years to replace, then why isn't there the obvious risk that our water consumption is now over-committed to a rate that threatens our community's viability, or is our projected water consumption and quality sustainable and maintainable, allowing for us to build out the remaining lots and construct other community projects in the future?

Response: Please see "§8438. Dust Control," which states: "(a) Water or other effective means shall be used to control dust where drilling, grinding or other dust-producing operations occur in accordance with Section 1538(a) of the Construction Safety Orders.

• The rental house on the corner of Askin and Maplewood has junk in the front yard. There is a roll of carpet, tire, truck cover and an aluminum boat sitting in the front yard.

Response: Thank you for letting us know. The EC Office is working with the owner to get the lot cleaned up.

• Over the past several years, I have noticed many homes with eight to 10 cars in front of their house, non-working vehicles, trash, fire hazards, etc. How do these residents continue to have these eyesores in our community without any recourse? Do we still have MOU (Memorandum of Understanding) policies? When the majority of us maintain our property with clearance, how come some people are getting away with this?

Response: Yes, we still have rules. If you see this happening, please get the address and send it to the general manager. We have also asked the board to assist with this. If they see something that is out of line, they are also asked to let the GM or the EC Department know. We just had 11 hearings, and we continue to cite to clean up properties, whether it is trash in the yard, weeds or because the house needs painting. As far as cars go, if they are registered, there is no limit to the number of cars allowed on a property. If they are non-op, they can have one, but it has to be covered. The EC Code 7.22 covers this, which can be found on the PMCPOA website at pinemountainclub.net/web/pages/pmcpoa-governingdocuments.

Wildlife Harmed by Rodenticides

CA Department of Fish and Wildlife

In late April, a dead owl was found on a nature preserve in San Luis Obispo County. California Department of Fish and Wildlife's (CDFW) Wildlife Investigations Lab (WIL) performed the necropsy and found excessive bleeding on the owl's leg and abdomen. With no associated wound or apparent trauma, additional toxicology testing was performed. Cause of death: fatal poisoning by anticoagulant rodenticides, chemical agents used for rodent control. For the WIL, it was the 13th raptor death by anticoagulant rodenticides since August 2019.

In a four-year study conducted by WIL biologists investigating the causes of mortality for hundreds of raptors – and 15 raptor species – across the state, more than 80 percent had been exposed to anticoagulant rodenticides. Roughly one-quarter of those raptor deaths were fatal poisonings directly attributed to anticoagulants. In a two-year statewide study, the WIL found that 96 percent of necropsied mountain lions showed non-fatal exposure to anticoagulant rodenticides. Almost one-third of those lions had been exposed to at least four different types of anticoagulants.

Throughout California, chemical baits used to control rodents have injured and killed non-target wild animals and pets. Anticoagulant rodenticides work by preventing blood clotting in the animals that consume it resulting in fatal bleeding. Predatory and scavenging birds along with mammals like raccoons, bobcats, foxes, skunks and coyotes that have eaten rodents that have consumed the bait can also be fatally poisoned.

The best way to protect wildlife is to use non-chemical means of rodent control. Habitat modification is an effective means of preventing rodents from inhabiting property. For example, many rodents like tall grass for cover. Mowing grass to no more than two inches makes it less appealing. Like most animals, rodents go where they feel safe and where food is available. The easiest way to discourage rodents from inhabiting property is to remove food sources and remove or modify anything that provides cover.

These simple actions can help:

- Keep your home / yard neat and clean.
- Keep tree branches and vegetation at least a foot away from home and roof.
 - · Seal any holes on your home and roof

where rodents can gain entry.

- Be aware that pet food, chicken feed and bird feeders will attract rodents.
- Remove objects and plants that rodents can hide under such as wood piles, debris, construction waste, dense vegeta-

tion and ground-covering vines like ivy.

- Pick up fruit that has fallen from trees as soon as possible.
 - Secure garbage in a tightly sealed can.
- Seal water leaks and remove standing water that may attract unwelcome animals.

partment of Fish and Wildlife has recommended prohibiting the feeding of birds and/or squirrels in an effort to prevent further bear-human interaction, and RE-SOLVED, that the PMCPOA Board of Directors approve RESOLUTION #02-07-18-2020, implementing the emergency resolution prohibiting feeding of

wildlife, including birds and squirrels, effective upon approval through November 1, 2020."

It is important we do not habituate our wildlife. Peanuts, birdseed, hummingbird nectar and other foods are bear attractants. Once habituated, the bears break into homes to find food, destroy property and people have been injured. We all need to remember, "A fed bear is a dead bear."
