Our World of Nature

Our Forests

By Lynn Stafford, Liz Buchroeder and Bill Buchroeder

Trees are all around us here in PMC. But what are they? Are they individual organisms locked in a to-the-death struggle with each other and all other creatures? This is the classic competition model for existence in nature. Each living thing is in a battle with other living things for life. Or is the situation more complex? Recent research has shown that there are intricate networks of roots and fungal strands in the soil connecting trees and other plants. These are called "mycorrhizal associations." Chemical analysis including using radioactive isotopes to trace movement of materials have shown that these organisms pass water, food and minerals back and forth along the network. The fungal strands create the connection between root systems and provide minerals and water to the roots. The plants supply food

Membership and Article 22

Bill Lewis II, Chairman of the PMCPOA Board

The recent approval of the rule change by the board regarding short-term rentals (Article 22 – Sections 22.03 B & C) took into consideration the possibility that the restrictions would create two classes of membership. The Board has investigated the issue of membership classes to include consulting with legal counsel and determined that:

Section 3.01 of the Bylaws does not bar the adoption of a short-term rental (STR) restriction notwithstanding the fact that it will only be binding on new owners.

Section 3.01 prohibits creating two classes of membership. However, we are not creating two classes of membership. Each lot has an equal membership interest, one vote per lot. (Bylaws, Art. IV, § 4.01.) Each lot has the same membership rights, i.e., to vote, to run for the Board, and to obtain corporate records. (Bylaws,

Note to Realtors: Please close your escrows by 12-31-2021 if your buyer is purchasing the property to operate as a short-term rental (STR). A rule change regarding STRs was passed by the board on Oct. 16, 2021 and is effective immediately. Your buyers need to know that if escrow closes after Jan. 1, 2022, they may not operate the property as a short-term rental.

to the fungi. And there is even evidence that neighboring trees of different species share resources.

Figure 1 shows a mature canyon live oak with young pinyon pines and oaks underneath it (note the hiker for size comparison).

Is this a "mother tree" providing shade and nourishment to these youngsters? Scientific studies indicate that this might well be true. Elder trees may be the hub of mycorrhizal transportation and communication between trees. This concept presents an entire-

ly different way of viewing the forest. It is already known that

Art. II.) The use of Association property for each owner is subject to reasonable rules adopted by the Board. (Bylaws, Art. II, § 2.3.)

The fact that the rental restriction would not be enforceable against owners purchasing before its adoption does not render it invalid. To the contrary, state law authorizes such disparate treatment. Civil Code Section 4741 expressly permits an Association to adopt a short-term rental restriction despite the fact that pursuant to Civil Code Section 4740(a) expressly restricts the enforcement of any rental restriction to those owners who purchase after its adoption. (See, Brown v. Montage at Mission Hills, Inc., 2021 WL 3701864 (2021).) The Board has authority to adopt rules governing the peace and enjoyment of the residents and the regulation of all matters consistent with the Civil Code. (CC&Rs, Art. 3, § 3.2(h); Bylaws, Art. IX, § 9.02E.) Rules may be enforceable even if they do not impact all owners in the Association. (See, e.g., Sui v. Price (2011) 196 Cal.App.4th 933, 939-940.)

The membership rights of current owners and future owners are the same. They are all governed by the governing documents. Nothing prevents a future Board from repealing this rule and, unlike bylaw changes, rule changes are not subject to a vote by members.

WINTER HOLIDAY SAFETY TIPS

PMCPOA Emergency Preparedness Committee

Winter holidays are a time for families and friends to get together. But that also means a greater risk for fire. Following a few simple tips will ensure a happy and fire-safe holiday season.

HOLIDAY DECORATIONS:

• Be careful with holiday decorations. Choose decorations that are flame resistant or flame retardant.

• If using an artificial tree, check that it is labeled "fire resistant."

• If using a live tree, cut off about 2 inches of the trunk to expose fresh wood for better water absorption, remember to water it and remove it from your home when it is dry.

• Place your tree at least three feet away from any heat source, like fireplaces, radiators, heaters and other heat sources, making sure to not block doorways.

• Do not overdo it on the lights. Check the lights' packaging for the power output and never plug in more than what a power strip or outlet says it can handle. You never want to connect more than three strings of lights in one series. Always look for the UL symbol when buying electrical items and pay attention to its color: green means it is approved for indoor use, and red means it can be used indoors and outdoors. If you are using old lights, check the wires to make sure there are no signs of fraying or cracking.

- Use clips, not nails, to hang lights so the cords do not get damaged.
- Keep decorations away from windows and doors.

CANDLES:

• Keep lit candles at least 12 inches away from surrounding objects. Trim wicks to a quarter of an inch before you light them, and only let candles burn for one hour for every inch of diameters, so the wax can melt evenly.

- Never leave lit candles in a room that is unattended.
- Consider using battery-operated flameless candles.

Before Heading Out or to Bed:

• Blow out lit candles when you leave the room or go to bed.

• Turn off all light strings and decorations before leaving home or going to bed.

Test your smoke alarms!

Please: Do Not Use Rodent Poison in Your Yard

A beautiful 4-year-old Huskey dog died in late October. She died a horrible, painful death in front of her owner at the emergency vet hospital. All because a neighbor thought it was prudent to poison all the squirrels and rabbits on their PMC property. A dying squirrel crawled into the dog's yard looking for water, and the dog picked it up and chewed on it, causing secondary poisoning.

There are apparently some PMC residents who are still using rodenticides (rat/mouse poisons). My question is, why would anyone move to the forest, and want to kill wildlife? Exclusion from your home, together with good housekeeping, is all that is required to keep rodents out.

Association Rule 7.11 states: Exposing wildlife to any toxic substance such as, but not limited to, poisons, automotive fluids, household chemicals or other harmful substances that may attract wildlife is prohib-



ited.

THIS RULE WILL BE STRICTLY ENFORCED. Fines for violating Article 7, Rules Regarding Wildlife, can range up to \$2,000.

A few months ago, letters were sent to all the local pest control companies informing them that bait boxes containing poisons of any kind are not permitted in PMC. I hope these companies are respecting this notice, BUT THE PROPERTY OWNER IS ULTIMATELY RESPONSI-BLE for ensuring POA rules are followed.

--- General Manager's Update ---

Snowplows are ready for snow! If you do not know the Snowplow Policy, please pick it up at the front office. We plow all main streets first to the highway. Secondary streets second, and then cul-de-sacs. Yes, you may have a berm to shovel. The association does not shovel out berms. The only situation when we take care of berms is if you have an ADA registration in your car or a doctor's note explaining why vou cannot shovel vour own berm. The berms will not be attended to until last. If you have a medical emergency, PLEASE CALL 911. They will alert the PMCPOA office that those medical vehicles are on their way, and staff will make sure that the medical vehicles have access to your home. A doctor's appointment, lunch with your friends or going to the market do not qualify as emergencies. We usually have notice when a storm is coming in, so please be prepared. If a car is parked on the street or children are playing in the street or culde-sac, your street will not be plowed.

The new Bobcat was delivered last month. Staff used the Bobcat to clear out the dead brush along Mil Potrero Frontage Road by the bed and breakfast, and it looks great. We expect our two John Deere carts to be delivered in December, and the large John Deere tractor to be delivered in January.

The Reserve Study called for the clubhouse roof and the maintenance roof to be replaced in the 20-21 year. Instead, we sealed the clubhouse roof and patched the maintenance roof to give the roofs two more years of life. Should the board or future board move forward with the additional phases of the facilities, the roofline of the clubhouse would change, and the money spent on a new roof would be wasted, as it would be ripped off for the new remodel.

The October financials shows the association is better than budget by 241,018. We still have one assessment to collect from 18/19, one assessment for 19/20, 22 assessments from 20/21 and 155 assessments for the 21/22 year.

The mailboxes at Tirol have a new cover, just in time for winter. The annual Halloween party for kids was in Lampkin Park this year. There were about 100 kids, and they had a great time decorating pumpkins and playing games along with the music. The Equestrian Center had the third annual Barn Bash, with about 300 people in attendance. There were crafts, horses in Halloween costumes

and a barbecue of hot dogs and hamburgers for \$7. Fun was had by all. At the time of this writing, we are looking forward to our annual Christmas Tree Lighting, and our annual Craft Fair, which came back onto the schedule this year after two years of cancellation due to COVID-19.

trees can communicate bark beetle outbreaks and other traumas to their neighbors. Now, research indicates that there may be intricate communication and transportation networks within a forest. Instead of nerve ganglia and axons, as in animal nervous systems, there are underground root and fungal pathways.

Current forest management practices, such as clearcutting and removal of elder trees, may be counterproductive. It is likely that members of the forest exist in a finely tuned system that benefits all the in-

Stafford and Liz **Buchroeder** habitants. We humans know little of this world that is hidden in plain sight. We tend to give artificial values to trees. Is it com-

mercially valuable? Does it look old and scarred? Is it just a dead snag? I will now focus on a few wonderful trees in PMC. The Jim Whitener ponderosa pine (Fig-

ure 2) is our best-known and largest tree. It stands close to Mil Potrero Highway in the Yellowstone Drive area, but is difficult to reach on foot. It appears quite healthy, although it lost its top a few years ago. The diameter near the base is 6 feet, 8 inches. Age estimates go from 400 years on up. We have two three-needle pine trees known as yellow pines in PMC. The common species here is the Jeffrey pine. The

Whitener Tree, plus a few other large ponderosas, may be remnants from a cooler and wetter past.

Near the Whitener tree was a large ponderosa pine that lived next to the highway.

higher and cooler portions of PMC. The large pines around the Business Center are

Jeffreys. Figure 4 shows one of the ordeals a tall tree must endure – lightning strikes. Lightning often travels down the outside of the trunk in the living tissue immediately below the bark, producing a linear scar. Jeffrey pines also provide homes for many animals. This great horned owl and her mate raised a family of two young in a Jeffrey pine close to the Post Office in 2018 (Figure 5).

Single-leaf pinyon pine is our most common, and least-appreciated, conifer. It doesn't grow very tall, is grayish blue in color and often does not look very majestic (Figure 6). However, pin-

yons are extremely important trees in our mountains. They occupy dry, hot slopes shunned by other conifers. Their rich pine nuts are favored by many animals and humans, alike. Their foliage offers hunting for insect-eating birds, such as the mountain chickadee (Figure 7).

There is a conifer tree in PMC that has been seen by very few people. It resides in an inconspicuous, little-visited canyon. It is a particularly large specimen (6 feet, 8 inches in di-

ameter) of an unusual species called the bigcone Douglas-fir (Figure 8). This tree is only found in Southern California. This giant thrives unseen within our community. PMC is still able to provide sanctuary for portions of the natural world.

Lastly, I would like to recognize a tree that does not occur in PMC but is

found in our mountains. This is the valley oak (Figure 9). The Community Park in Frazier Park has a heritage grove of venerable oldsters. Some community activists are working to protect these trees and young saplings appearing around them.
